I, the undersigned further agree that **a \$100 overtime fee will be charged for weddings starting 30 minutes late** and that due to other weddings scheduled, ministers are not always able to wait. Cancellation must take place within 24 hours of wedding by calling (831) 601-5553 (emails are not accepted) or I the undersigned will be responsible for full payment of services. By law, I must be 18 or older and residing together and provide the proper I.D. and divorce papers if divorce is less than three months old, if *A By-the-Sea Wedding* is issuing my marriage license. **DEPOSIT IS NON-REFUNDABLE.**

ABOUT YOUR MARRIAGE LICENSE

(MUST BE LIVING TOGETHER AND AT LEAST 18 YRS. OLD IN ORDER TO USE THIS LICENSE. PHOTO I.D.'S AND DIVORCE PAPERS MUST BE PRESENTED IF DIVORCE IS LESS THAN 3 MONTHS OLD)

You were married under the authority of the State of California using California Family Code 530. This approach is known as a "Confidential Marriage" and as such your marriage certificate is not open to public inspection.

If you had been married under the authority of a Public License issued by the County Clerk, your license would be open to public inspection. Anyone who wishes may go to the County Clerk's office and look at marriage licenses. They may do this for any reason. Many businesspeople regularly look through the marriage licenses to get information about people which may be used for various solicitations such as the sale of life insurance.

But your Confidential Marriage License is NOT available for this purpose. Only you may get certified copies of the License. You are the one who controls access to the document. If someone wants a copy of your license and you refuse to give it to them, they will have to get a court order to obtain it. Of course, the court would not give such an order to anyone without good cause.

If anything happened to the two of you, your family might not know how to get a copy of your Marriage certificate to prove they are related to you. Therefore, you should keep a certified copy with your important papers. It is also important to remember where your marriage license is filed so you can get additional copies if you need them.

The Confidential Marriage License we issue is filed in Monterey County. You can always request additional copies of your marriage license by contacting the <u>Monterey County Clerk</u> and asking them what information they need to order additional copies. The current fee for certified copies is \$15, but this can change.
